This release applies to any liability arising from negligence, breach of duty, or otherwise, to the fullest
extent permitted by the laws of Saskatchewan and Canada.



NO LEGAL ACTION

I agree not to commence or maintain any claim, action, or lawsuit against the Festival, its organizers, or associated parties in connection with any accident, injury, illness, loss, or damage that I may sustain while volunteering, except in cases where such exclusion is prohibited by law.

MEDICAL CONSENT

In the event of injury or medical emergency, I authorize the Festival organizers to secure medical treatment deemed necessary. I accept responsibility for all related costs.

VOLUNTEER CODE OF CONDUCT

I agree to follow all safety instructions, Festival rules, and directions from organizers or supervisors. I understand that failure to comply may result in dismissal from volunteer duties.

GOVERNING LAW

This agreement shall be governed by and interpreted in accordance with the laws of the Province of Saskatchewan and the applicable laws of Canada.
